1. If for any reason buyer is not able to keep this pup/dog, it must be returned to breeder with all necessary paperwork signed and turned over without any money refund.
2. Buyer Agrees to start the name of the puppy with the alphabetical letter that the breeder indicates, and use the kennel name "Vom HochKlasse" as the prefix in the registered name of the dog, Otherwise the contract and guarantee will be void
3. Maintain up to date vaccines, wormings, and to keep the dog / pup in humane conditions, providing proper food, water and shelter.

### HEALTH GUARANTEE

**Your puppy from Vom HochKlasse Kennels is guaranteed...**

1. The Puppy came with 2 years guarantee of any genetic Health Diseases, Including Dysplasia, It is the responsibility of the buyer to show breeder a letter from the veterinarian stating and signing that the problem is genetic and not caused by any negligence of the owner.  
Shipping costs and veterinary costs will be covered by the buyer.

### **Show/Breed Guarantee**

This Puppy has been sold to Buyer by Seller as "Breed/show prospect". shall be understood to mean that no disqualifying faults as defined in the standard are evident at time of sale and further that no genetic disorders are immediately apparent.

1. Should Puppy develop any disqualifying faults as defined in the Standard, or be diagnosed with any genetically derived medical disorder which is confirmed by two unassociated veterinarians, or disqualify for two different judges in the show ring, thereby causing Buyer and Seller to agree that Puppy cannot ethically be bred, Seller will, upon provision of veterinary reports and, where applicable, Orthopedic Foundation for Animals (OFA) report, or Canine Eye Registration Foundation (CERF) certification, provide Buyer with one of the following options.

a) Should Buyer choose to relinquish ownership of Puppy to Seller, Seller will replacement that puppy for another "Breed/show prospect Puppy" at no cost to Buyer. Buyer pay shipping or miscellaneous charges associated with transport.

2. Seller shall not be held responsible for the development of disqualifying faults, diseases, or disorders, which are due to Buyers negligence.

3. Buyer agrees that Puppy shall not be used for breeding purposes until the OFA certifications have been received by the Seller:
